The Saskatchewan government announced a five phase 'Re-Open Saskatchewan Plan' which includes golf courses opening May 15 with guidelines, as a part of phase 1. This is a positive sign that golf is recognized as a safe outdoor activity when proper social distancing is being followed. The 2020 golf season will be different than anything we have experienced, but we are fortunate that Saskatchewan has done so well in keeping numbers low.

Our policies and procedures will be adjusted during this unprecedented time and you will receive email correspondence for updates.

Moon Lake Golf and Country Club is **accepting tee time** reservations. Booking access will be available online through our website [www.moonlakegolf.com](http://www.moonlakegolf.com) Phone reservations will be available with 7 days advancement by calling the Golf Shop 306-382-5500.

**Online booking will be preferred** due to the card on file process.

\*\*To use the online booking system, you will need to have an email attached to your profile (if you are a prior guest). This can be added by calling the Golf Shop at 306.382.5500 or texting 306.400.5440 with your name, email address and phone number. If you have your email address in your system but do not have a password set up or have forgot your password, you can enter your email address and hit the 'forgot password' tab and a temporary password will be sent to your email address. The online booking process will prompt you to set a card on file, if you already have done so, you can hit the 'use card on file' tab to proceed.

**Moon Lake Golf and Country Club - Phase 1 Guidelines:**

- Memberships must be done through the office by calling 306-382-7787 ext. #31, Monday - Friday, 9:00am – 5:00pm - prior to booking
- No cash transactions – All golfers must have credit card information on file
- No Walk-ons, pre booked tee times only
- All members must check in NO Exceptions
- Changes/Cancellations to tee times may be made up to 12 hours prior to your booking time. Any changes made within 12 hours of your tee time will result in your card being charged the full amount. (Please be mindful to book for the correct amount of players ex: booking a foursome and showing up with two players will result in a charge to your credit card)
- Power carts are not guaranteed to be available - walking is encouraged. Disinfected after each use
- Please do not arrive more than 20 minutes prior to your tee time
- Hand-sanitizing locations for your sanitary practices
- Lockers, Club Cleaning and Storage are not available
- Players exhibiting signs of illness will not be permitted to play
- Physical distancing, must be observed at all times, with a minimum of two metres between Individuals
- Flags must remain in place and cups elevated so the ball does not drop into the hole. Play is concluded when the ball makes contact with the cup
- All food and beverage service is available subject to the Restaurants and Licensed Establishments Guidelines
- Do not share any food, drinks, or smoking devices

We must continue following the guidelines recommended by the Saskatchewan government and local health authorities to continue to flatten the curve. As we find ways to enjoy golf, the health and safety of our members, customers and staff will remain our top priority. Thank you for your patience as we navigate through Covid-19.
